Dear Mr. President,

We, the officially appointed representatives of the administrative governments of the states Federal State of Bavaria and Federal State of Baden, Department of Foreign Affairs, convey our warmest greetings to you Mr. President.

We speak for all of us, the indigenous German folks of Bavaria and Baden. We accede our legacy according to the governing laws of the last existing state order, in the state areas of the German 2nd Reich, the German Confederation (Staatenbund Deutsches Reich), that was existing two days before the outbreak of World War I, and which never perished by an act of international law during and after the WW.

Further, we took <u>actions of denazifying</u> ourselves by expressing our opposition to the nationality "deutsch" that was enforced to us during the regime of the National Socialists and which continued until today through the trusteeship Federal Republic of Germany (FRG). We returned our ID documents to the FRG managements, enclosed with the Letter of Intent, terminating the invisible contracts of "voluntary" submission to the ruling power of the FRG. These invisible contracts are associated with the loss of all legal entitlements to our human rights, land and territory.

The law of nationality that is still in place until today called, *Reichs- und Staatsangehörigkeitsgesetz* (RuStAG) from the date July 22, 1913, defines the principle of "blood rights" – <u>ius sanguinis</u> – and serves as a proof of our ancestry to the native/indigenous German Folks (Prussians, Badenians, Bavarians, Saxonies, Wurttembergers, etc.) within the German Confederation (Staatenbund Deutsches Reich); and guarantees the sovereignty of our land and country.

The state "Freistaat Preußen" (Free State of Prussia) has begun the process of international legal reorganization through continued practice of *persistent objector* in 2012 and has freed itself with it from the occupying-juridical post-war order. In the year 2015, as the right-holder of the presidium, it made the German Confederation (Staatenbund Deutsches Reich) capable of acting again.

Since then, the other members of the German Confederation (Staatenbund Deutsches Reich) begun the process of international legal reorganization by means of emergency election held in crisis as subjects of international law, e.g. state Federal State of Bavaria and state Federal State of Baden. Each elected administrative governments took over the international-law order of the registration and documentation of the nationality of each native/indigenous German folks in their respective Federal States, in accordance with RuStAG.

The states Federal State of Bavaria and Federal State of Baden are existing subjects under the international law justified in state contracts with the Free State of Prussia concluded on September 03, 2016. Therefore Bavaria and Baden do not belong any more to the scope of the national-illegal Weimar Republic.

We, the Citizens of the States Federal State of Bavaria and Federal State of Baden, Take over the Function of persistent objector and Demand the Observance of Conventional Law - ius cogens -

We Do Not Renounce Our Land Rights, But Demand the Release of Our Land Back to Us.

The FRG and its 16 provinces are not recognized as a <u>state government and therefore</u>, not a <u>subject under the international law</u> here in Europe. Its function is exclusively as the private management of the United Economic Areas introduced by the West Allies with the aim to further use the German people... solely to its <u>own advantage</u>. To maintain this aim, the FRG must exercise control over and fight against all Germans, especially against the German citizens that have denazified themselves as native/indigenous German people!

By joining the United Nations (UN), the trusteeship Federal Republic of Germany made a conflicting action to itself and the German folks and made them to its own "enemy" in accordance with the stipulations of articles 53 and 107 of the UN charter. Being a legal successor of the German 3rd Reich, the FRG continues to enforce the nationality "deutsch" to the Germans as done by the National Socialists in 1934.

The so-called 'Two plus Four' (2+4) -Agreement concluded on September 12, 1990, is an agreement between the four allied occupying powers of WWII and their introduced management till 1990, the FRG and the GDR. This Agreement did not in fact give back the sovereignty to the native/indigenous German people in any way or respect.

Hence, the FRG still sees its continued power/authority to act deliberately against our denazified and certified indigenous citizens of the Federal States of the German Confederation (Staatenbund Deutsches Reich) and consider them as equivalent to the citizens of the German 3rd Reich. By disregarding its administrative order, and breaking the conventional law, the FRG, thereby commits a genocide of the native/indigenous German folks by applying the "Stasi-Methods" of daily dishonor, existence destruction, defamation, looting and deprivation of freedom, flanked by wrong propaganda "Fake news" of the dependent leading media.

The FRG uses relentlessly its monopoly of power and profits from the ignorance and dependence of its employees under its ruling power in the management. Their representatives suppress, deny everything, and denounce any measures of finding the truth, enforcement of valid international and conventional laws, and for the protection of the native/indigenous German folks.

We, the native/indigenous folks Federal States of Bavaria and of Baden turn to you, with this crisis, Mr. President, with the consciousness of your leadership position and historical responsibility as a victorious power of the WWII.

The installed post-war (WWII) order, leads to the destruction of our native/indigenous German folks, through the established trusteeship (FRG), who are evidently going to execute all efforts for the <u>final</u> <u>extinction</u> ("Endlösung") of our native/indigenous German folks.

Please, help STOP the violation of the international law and injustice in Germany after more than 99 years!

Pave the way for our German indigenous folks to restore the statehood in accordance with the international and conventional laws, in spirit of peace, by means of the international law restitution which is obliging for all partners of the post-war order, in particular for the United States of America.

The German Confederation (Staatenbund Deutsches Reich) has introduced a new legislation "Ausführungsgesetzte zur Restitution/Reorganisation" (AzRR) on November 27, 2016 for the peaceful transformation of the trust management FRG into a state administration. Completely in support of the SHAEF-law with the restoration of peace and order in the occupied German areas after the WWII.

We, the officially appointed representatives of the native/indigenous German folks Federal States of Bavaria and of Baden, ask you, Mr. President to stand steadfastly by our side, as a protective power, protecting us against the FRG managements and support us to end the international-illegal occupation of our sovereign state territories.

May we remind you of your German roots which reach to the German village of Kallstadt, Palatinate. The FRG uses its monopoly of power relentlessly to cut these roots for good.

In view of the above, we request you, Mr. President by all respect, to answer to our urgent call for help:

- **I.)** Please, use all possibilities, both political and diplomatic, with your influence, so that the FRG would stop the genocide.
- **II.)** The states Federal States of Bavaria and of Baden, reorganizing in accordance with the international conventional law, and in account of its internationally justified restitution duty, are to be recognized in the international community of states, as well as by the FRG. Please commit yourself for their international and diplomatic <u>Recognition</u>, as existing subjects under the international law.
- III.) Please give us the contact information of your military installations within Germany to whom the national-illegal infringements of the FRG on citizens can be announced and may provide essential assistance in emergencies.
- **IV.)** Please inform and authorize the investigating agencies of your military public prosecutor's offices because the authorities of the FRG are not responsible for the indigenous citizens of the Federal States of the German Confederation (Staatenbund Deutsches Reich) under international law.

With the deepest wish in our hearts, inspired by our soul, to finally create an end to the worldwide, international-illegal state of war, to make peace with all people on earth, to respect the borders of all sovereign states, to carry on fair commerce on the basis of the peaceful coexistence, and to close friendship with other people, or to make new ones, combined with the best wishes, and goodwill to all Mankind, we remain,
